

#### **Company Overview**

- Second largest publicly traded BDC with ~\$15.4bn of AUM
- Operates within KKR's \$200bn credit platform and \$78bn private credit strategy<sup>1</sup>
- Traded on NYSE under ticker symbol "FSK"
- \$5.5bn market cap with average daily volume of 1.1 million shares
- Regulated under the Investment Company Act of 1940; Leverage limited to 2:1 ratio of equity

- FSK invests predominantly in private US based companies with \$100mm+ of EBITDA
- Portfolio consists of 200 issuers across 24 different industries<sup>2</sup>
- Weighted average annual yield on accruing debt investments of 12.1%<sup>3</sup>
- 68% of investments are first lien senior secured debt and 89% of debt investments are floating rate<sup>4</sup>


